OBJECT OF THE AGREEMENT

THE STUDENT AGREES TO

- abide by the guidelines on research ethics and good scientific practice issued by the National Advisory Board on Research Ethics in Finland
- professional confidentiality
- use the client's data for the above-mentioned purpose only
- refrain from disclosing or publishing identified or identifiable data from the client's materials
- deliver the finalised thesis to the client and, if possible, present the results to the client.
- These clauses shall remain in force even after the thesis is published.

THE CLIENT AGREES TO

- enable the gathering of data
- guide the student in professional questions relating to the thesis
- cover thesis-related costs in accordance with a separate agreement if one exists.

THE SUPERVISOR IN THE CLIENT ORGANISATION AGREES TO

• guide the student in professional questions relating to the thesis.

TERMINATION OF THE COOPERATION AGREEMENT FOR THESIS WORK

The client is entitled to terminate the cooperation agreement if the thesis work is interrupted for reasons relating to the student. The student is entitled to terminate the agreement if the work cannot be carried out due to compelling reasons such as data becoming impossible to acquire. If the cooperation agreement is terminated, all materials collected for the thesis shall be returned to the client.
